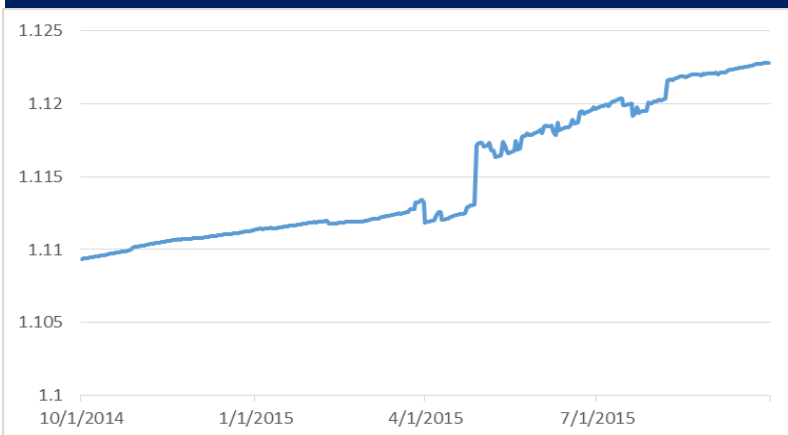

**NAVPU OVER PAST 12 MONTHS**

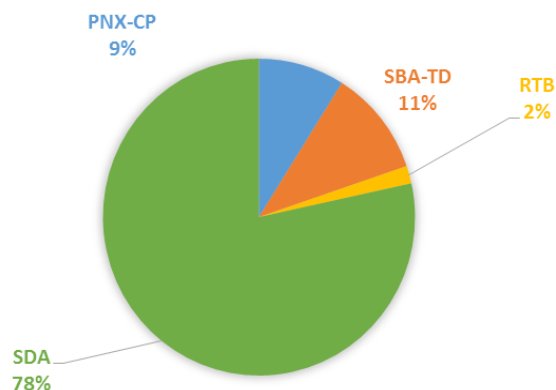

**RELATED PARTY TRANSACTIONS.** The Fund has deposits with the Bank Proper amounting to PHP624,073.89, which was approved by the Trust Committee. Likewise, all related parties transactions are conducted on an arm's length basis.

**OUTLOOK AND STRATEGY.** BSP maintained its policy rates, due to low inflation environment. Headline inflation for the first nine months of the year was at 1.6% which is below the low-end of its target range. Sterling Bank of Asia - Trust Group will maintain a short term duration portfolio to mitigate volatility due to the uncertainty in the Fed Rate hike and the possible effects of El Niño.
