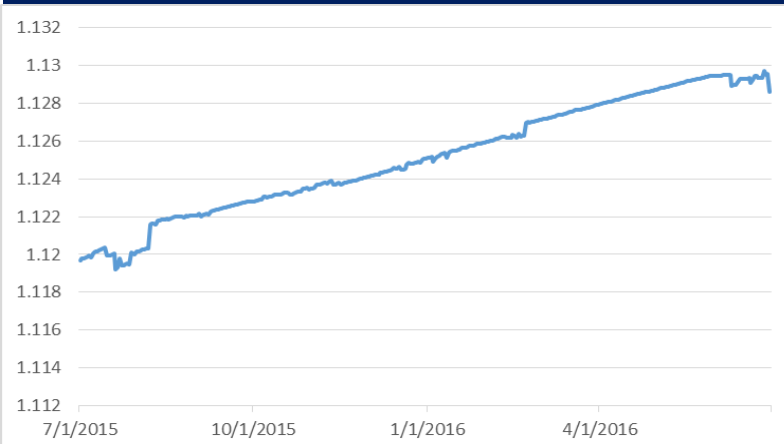

**NAVPU OVER PAST 12 MONTHS**

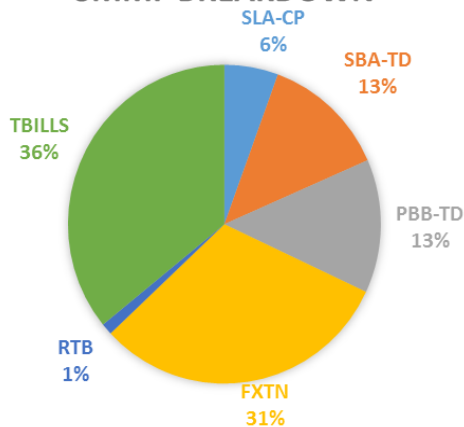

**OTHER DISCLOSURES**

**RELATED PARTY TRANSACTIONS.** The Fund has deposits with the Bank Proper amounting to PHP1,145,731.43, which was approved by the Trust Committee. Likewise, all related parties transactions are conducted on an arm's length basis.

**OUTLOOK AND STRATEGY.** June inflation stood at 1.9% bringing YTD inflation to 1.3%, which is still within BSP targets. BSP has folded its Special Deposit Account facility into the Overnight Deposit Facility in June. BSP also launched the Term Deposit Auction Facility as the main tool to take in excess liquidity in the market. The regulator has cut the overnight borrowing from 4% to 3% and the overnight lending rate from 6% to 3.5%. Sterling Money Market will continually look out better yields in the current low rate environment.
